Panel Discussion

Background

Beyond a reflection of the past, culture is a living force with the potential to foster a peaceful and sustainable future for all humanity. Across the globe, culture embodies the stories, wisdom, and values that shape nation's identity and promote resilience, especially in the face of complex global challenges.

Economically, culture is an engine of growth. It drives innovation, generates revenue, and creates jobs that contribute to alleviating poverty. It is estimated that culture and creativity account for 3.1% of global Gross Domestic Product (GDP) and 6.2% of all employment, underscoring the imperative of sustained investment in this sector. Not to mention the equally powerful role of culture in addressing climate change. Arts can inspire action and increase public awareness, while traditional knowledge and local practices offer adaptive models for living in harmony with the environment.

Yet, culture today faces unprecedented challenges, especially in this era of globalization and digitization. While new technologies present opportunities for innovation and creativity, they may affect societal norms and foster cultural homogenization, which risks overshadowing traditional and local practices and values. These challenges are exacerbated by issues of, among others, illicit trafficking of cultural objects, conflicts, and the intensifying impacts of climate change.

In this regard, CHANDI 2025 is convened to affirm the role of culture as a driver of sustainable development, peace, and climate resilience by fostering dialogue, innovation, and collaboration. Central to CHANDI 2025 are **panel discussions** that bring together practitioners, academics, communities, and civil society to chart collective and effective actions to address illicit trafficking of cultural objects, respond to climate change and foster culture-based climate action. The panels will also highlight strategies to unlock investment for cultural preservation, and explore how traditional knowledge and local practices can strengthen resilience.







As part of the program, four high-level panel discussions will be organized, each cohosted by a leading institution and/or organization engaged in cultural heritage issues. These sessions will also produce actionable recommendations and foster collaboration to safeguard culture, ensuring that it continues to serve as a source of identity and creativity.

Objectives

- Promote dialogue on the protection and promotion of cultural heritage amid complex global challenges.
- Highlight best practices, case studies, and approaches that can strengthen policy frameworks at national and international levels.
- Develop policy recommendations and collaborative frameworks.
- Foster and strengthen cooperation among countries and other relevant stakeholders on cultural heritage and its related issues.
